Marco Salgado and Pilar Ay participate in a new version of LawWithOutWalls - DLA PIPER CHILE



Every year the University of Miami organizes an innovation and entrepreneurship competition. On April 14 and 15, the final phase or ConPosium of the **LawWithOutWalls** program was **developed** , an

initiative that brings together more than 100 students from more than 30 leading universities worldwide.

On this occasion, two students from the Pontificia Universidad Católica de Chile, Macarena Infante (graduated) and Juan Franco (fifth year), had to solve a problem with their team of Law and Economics students and then present their project under the modality Business Pitch **The young people were accompanied by the UC law professor and partner of our**



office Marco Salgado, who participated as a Faculty Leader, together with the former student of the PUC and DLA Piper Chile associate Pilar Ay, as an Alumni Ambassador. In addition, DLA Piper Chile sponsored the participants.

Macarena Infante worked on the challenge focused on improving, in the least technological way possible, the contractual process that takes place daily in the internal prosecutor's offices or legal departments of the companies. Juan Franco, meanwhile, worked on the problematic *Machine Rebellion: How can the increasing use of drones be regulated efficiently and how can technology be used to enforce regulation?* In this framework, the UC Law student team developed a mobile application that provides the user of a drone all the regulations in real time, with instant warnings in case of contravention, which describe briefly and concisely (user-friendly) what is it what is wrong

The Faculty of Law of the PUC participates in this global initiative since 2012, being the only Faculty at the national level that participates in the LawWithoutWalls challenge.
